Minority home purchases increased as a result of expanding our culturally specific education services.

"In 2014 we launched *Su Futuro*, a Spanish language, financial education class. It was modeled after *Getting Your House in Order,* our culturally specific course designed for African Americans.

Both of these courses rely on Advisory Committees made up of leaders from culturally corresponding communities.

The classes were delivered in partnership with employers of large numbers of Latino or African-American employees.

From what we've learned creating these classes, we published a report, in collaboration with PSU; allowing us to share our expertise with the Portland community."

In 2014 we proved that PHC can produce. We know how to grab on to new programs and get them out into the community.

"PHC was selected as the twenty second Wells Fargo Home Foundation NeighborhoodLIFT site. This is important because we finished the program early - 6 months, instead of the 2 years set in the contract, 470 households received a conditional 2 month reservation of LIFT funds and, by year end, 253 households bought homes. This is also a testament for the strong desire of people to purchase homes in Portland, considering there was one month of inventory of homes for sale."
