### **OUR STORY**

Founded in 1991 after damning local news exposed declining rates of homeownership in once-thriving majority-Black neighborhoods in inner Northeast Portland due to bank redlining, fraudulent home loans, and rampant housing discrimination. PHC seeks to redress the racial inequities that persist from this shared history by returning wealth and power to Portland's communities of color through homeownership.

Since 1991, <u>more than 10,000 households</u> have purchased their first home with the support of PHC's services.

# Dana Shephard Executive Director



### It truly is a full circle moment.

Homeownership profoundly shaped the trajectory of my life, and now I have the opportunity to shape the trajectory of PHC to broaden and deepen that transformative impact for others.



**On January 1st, 2023,** Dana Shephard assumed the role of Portland Housing Center Executive Director, only the second person to hold the post. Dana was appointed after a rigorous and intentional search process to replace outgoing Director, Peg Malloy, retiring after 31 years of service as PHC's Founder and Executive Director.

A 4th-generation Portlander, Dana brings over twenty years of experience in housing low-income households, including eight years at the City of Portland's Housing Bureau working with local non-profit organizations, Community Development Corporations, and nonprofit developers to address racial disparities in housing and funding for culturally specific non-profit housing and repair agencies.

As Program Manager at the city she worked closely with PHC and other organizations to administer homeownership and retention programs. The "Preference Policy", part of the city's N/NE Neighborhood Housing Strategy addressing the legacy of displacement in North and Northeast Portland, has, to date, created over 110 new first-time homeowners, the majority from Black-identifying households.

**Dana's decade long relationship with PHC** includes working as a PHC Homebuying Specialist early in her career, serving on PHC advisory committees to strengthen programming for the Black and African American communities, and officially returning to PHC as Deputy Director in January 2022.

**Most significantly, Dana's** *first experience* **with PHC** was utilizing the organization's Mortgage Assistance Program to purchase her own first home at the age of 22.

#### Letter from the Executive Director

Dear Community,

I am honored to address you in my capacity as the Executive Director of the Portland Housing Center. As I assumed the role at the beginning of 2023, I embarked on a journey that was deeply rooted in my personal connection to this organization, and I'm grateful for the opportunity to lead PHC into the next phase of our mission.



The past fiscal year has been marked by unprecedented circumstances, particularly as we grapple with a housing market that continues to be characterized by the highest interest rates in a generation, and stubbornly high home prices which are increasingly out of reach for households of more modest means. The ramifications of these market conditions have been acutely felt by those we serve, further exacerbating the existing disparities in homeownership and exposing an ever widening gap in incomes and wealth, especially for people of color.

In response to the challenging environment, we have adapted our programs and services to better serve our community and secured new opportunities and resources to support our efforts. I am proud to share that we were awarded over 1 Million dollars in new down-payment assistance resources in the past fiscal year. We were also grateful to secure a capacity building grant of over \$400K, as well as grants to renew and strengthen our internal commitment to diversity, equity and inclusion which has allowed us to recruit, promote, train and support additional staff and board members, as well as reintroduce Spanish-speaking course offerings, after a two-plus year pause.

My goals for our new fiscal year and the years ahead are ambitious, but critical to maintaining our ability to serve our communities responsively and with cultural competence in these uncertain economic and historical times.

- We will be strengthening existing relationships, and forming new ones through deepening our community outreach.
- Fiscal year 2024 will see us launch a strategic planning process, diversify our revenue sources, and explore the potential of investing in the development of new homes in order to create affordable inventory for households in our pipeline.
- The task of finding right-sized and low-barrier down-payment assistance to help our low-income households purchase has never felt more urgent, and we will continue to advocate on many fronts for increasing those opportunities.






